- An additional daily surcharge will apply to Corporate Rate rentals of <u>\$3.00</u> in Winnipeg MB, <u>\$5.00</u> in Edmonton AB, and Toronto ON.
- 5 For rentals if the vehicle is not returned to the renting city, and for rentals of car classes 5 other than those indicated above, a <u>5%</u> discount off Standard Daily rates will apply, plus any applicable inter-city drop-off fees.
 - The above Corporate Rates are available at all Participating, Corporate and Licensee locations and require a confirmed reservation. Corporate Rates are subject to vehicle availability and may require a guaranteed reservation. Corporate Rates may not be available during periods of peak demand. During those periods, daily rates less any applicable discount shall apply. All one-day Corporate rentals commencing on a Tuesday or Wednesday will be charged an additional <u>\$5.00</u> surcharge.

All renters are required to meet Hertz's standard qualifications in effect at the time and place of rental for financial responsibility and for renting or operating Hertz vehicles. In Canada the minimum age for any renter or fellow employee authorized operators to receive any rates, discounts or other benefits under this agreement is age 20 on all vehicle classes except prestige where minimum age is 25. Standard age differentials do not apply.

For business rentals only, fellow employees are Authorized Operators. They are not required to complete an additional form, be present at time of rent or pay an additional fee.

Airport Concession Fee Recovery applies to Corporate Rate rentals at Airport locations that currently apply such fees.

Except as otherwise provided herein, all other charges Hertz may impose in connection with a rental – including, but not limited to, taxes; surcharges; charges for the purchase of loss damage waiver; insurance coverage of any type; vehicle upgrade charges; delivery and collection, one-way and drop charges; airport and other concession fee recoveries; vehicle licensing fees and fee recoveries; other expense recoveries; additional driver and age differential charges; currency conversion charges; and charges for child seats, ski racks, fuel, refueling, and navigational services – are not included in the rates. Where imposed, no discount shall apply to such other charges.
