Additional information (NTO, invoice or previous release referencing project) might be required. Please submit a new request if additional information has been requested.

### **TYPES OF RELEASES**

#### 1—CONDITIONAL PROGRESS (THROUGH DATE REQUIRED EXCEPT FOR NEVADA JOBSITES.)

Will include all open invoices for the project through requested date. If invoices from the previous month's release remain open, these will be listed as exceptions.

#### 2-UNCONDITIONAL PROGRESS (THROUGH DATE REQUIRED EXCEPT FOR NEVADA JOBSITES.)

All payments must be posted to customer's account and all invoices for project closed through date requested. (This includes all adjustments.)

#### 3—CONDITIONAL FINAL

Completed after all equipment has been picked up from jobsite and billed. Will include all open invoices for project.

#### 4—UNCONDITIONAL FINAL

Completed after receipt and clearance of final payment for project and all invoices closed.
