# Hertz competition terms and conditions

# WHO CAN ENTER?

- To be eligible to enter the Hertz Audi Car Giveaway Competition (competition) you must:
  - be over the age of 18; and
  - reside in Australia.
- Employees of Hertz and Audi, their spouses, parents, grandparents, children, grandchildren, brothers and sisters, brothers in law, sisters in law and any agencies associated with this competition are ineligible to enter.

# **HOW TO ENTER**

- The competition period commences at 00.01am AEST on 1 August 2016 and ends at 23.59pm AEST on 30 September 2016 (competition period), and Hertz reserves the right to extend the competition end date at any time (subject to regulatory approval, if required).
- To enter the competition you must rent a passenger or prestige vehicle within the Hertz fleet for a
  minimum of 3 consecutive days using the advertised promotional code at the time of booking.
  Rental bookings must be made during the competition period with the rental period occurring
  between 1 August 2016 to 30 November 2016.
